FIRST AID:

HEALTH EFFECTS

ACUTE:

- Swallowed:** Considered an unlikely route of entry in commercial/industrial environments. Ingestion may result in nausea, abdominal irritation, pain and vomiting. Ingestion of anionic surfactants may produce diarrhea, intestinal distension and occasional vomiting.
- Eye:** Raw detergent irritating to eyes.
